This includes reviewing and analyzing relevant government legislation and policy frameworks to understand implications for AHMA member societies and BC's Indigenous housing sector in BC. Additional responsibilities include planning and coordinating complicated projects with a range of stakeholders, preparing concisely written briefing notes and research reports, conducting literature reviews/environmental scans of both academic and grey literature, qualitative and quantitative data analysis, as well as preparing meeting materials and coordinating project team meetings and external advisories.

This role supports AHMA's Operations execute and advance key policy and research initiatives in identified in our strategic plan to advance Indigenous housing rights and interests of Indigenous housing providers across BC.
